This section of the course will cover the various principles of measurement uncertainty and the necessary methods for generating formal measurement uncertainty budgets as required in ISO/IEC 17025:2005 and recommended practices through the Guidance of Uncertainty of Measurement (GUM) and other practical methods. Participants will be educated on the development of uncertainty budgets and will be provided with measurement uncertainty templates that can be utilized in their own testing or calibration laboratory. Participants will exit this course with the knowledge on how to determine relevant factors when determining measurement uncertainty and how to calculate the results.

Key points for this course:

- Identify Measurement Uncertainty Contributors
- Assign Magnitudes to each Contributor encompassed in a Measurement Uncertainty Estimate
- Conduct mathematical methods for combining uncertainties from multiple contributors
- State appropriate Expanded Uncertainties derived from the collected information
