PJLA attended and presented at the ASTM D37-Workshop on Advancing the Field of Cannabis/Hemp through Standardization -Rome, Italy:

Alessandro Annino represented PJLA at the ASTM D 37 Workshop in Rome, Italy on February 18-19, 2019. This included and overview of cannabis testing laboratory accreditation challenges in the United States including, Internal Method Validation. This presentation discussed the appropriate criteria for validating internal methods based on well- known industry practices and ISO 17025. This presentation allowed for members of the working group to intake information on how to develop criteria for this common issue to be utilized by cannabis testing laboratories globally.

PJLA at the Food Safety Consortium 2018:

PJLA visited the 6th Annual Food Safety Consortium Conference and Expo from November 14-16 in Schaumburg, Illinois. The conference focused on



food safety education and networking, providing attendees' information on best practices and new

technology solutions to today's food safety challenges. Representatives from the world's leading accreditation bodies met for a panel at the consortium, where they discussed the new ISO standard, the future of the cannabis

PJLA Evaluated By APAC For Our ISO 15189 Accreditation Program

ILA accredited our first clinical laboratory, Personal Genome Diagnostics, to ISO 15189:2012 in 2017. When their reassessment came up due in January, 2019, we selected them as the candidate for our APAC ISO 15189 scope extension evaluation. They graciously welcomed the representative from APAC to join us for their reassessment during the week of January 21st. APAC spent 2.5 days onsite observing our assessment process and conducted an office evaluation here at our at headquarters in Troy, Michigan. The overall evaluation was very successful and it's expected that PJLA will received our approval for signatory status to APAC MRA by the 2nd quarter 2019.





According to Halima Alli, Technical Program Manager, Personal Genome Diagnostics (PGDx) represents one area for the growth of our ISO 15189 Medical Program. Having achieved accreditation to ISO 15189 for their laboratory operation in Germany, PGDx sought accreditation for the laboratory in Baltimore as well. International clinical trials require standardization across all laboratories performing testing to qualify patients, and assess the effects of treatments. Such testing needs to be performed to the same standards of quality and reliability expected for the diagnosis of disease. ISO 15189 is the ideal solution as an internationally recognized, and applied standard. Accreditation to ISO 15189 is an indication of the rigor and quality of a lab's testing and informs decisions for grants and inclusion in development projects. •


